Details: Mariners and port users are advised that the **5 knot speed limit zone** for the **Williamstown Maritime Precinct** within the port waters of the port of Melbourne (refer attached chartlet), is now established with immediate effect as a waterway rule under **Schedule 2** of the **Vessel Operating & Zoning Rules for Victorian Waters** (VOZR).

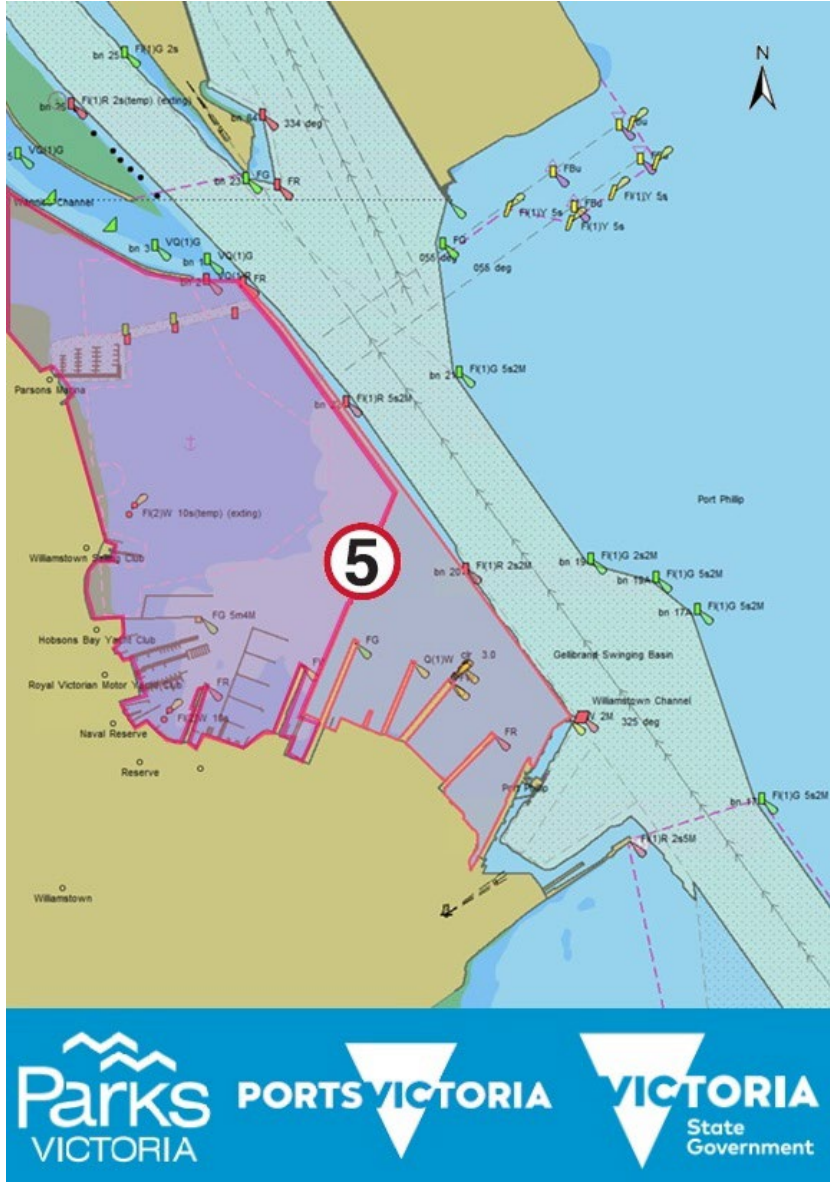

CONSEQUENTIAL RULE

I, Chris Banks, Executive Director Safety Strategy and Regulation (delegate of Safe Transport Victoria) make the following consequential rule under section 185 of the **Marine Safety Act 2010** which is consequential to the making of the waterway rules below.

The rules regulating the operation of vessels on the waters of The Local Port of Port Phillip as detailed in Clause 1.5.7 of Schedule 1 The Local Port of Port Phillip, made in the Notice under section 184 of the **Marine Safety Act 2010** and published in the Victoria Government Gazette No. S 142 on 5 June 2015 is revoked.

WATERWAY RULE

I, Chris Banks, Executive Director Safety Strategy and Regulation (delegate of Safe Transport Victoria) make the following waterway rule under section 184 of the **Marine Safety Act 2010**.

SCHEDULE 1: The Local Port of Port Phillip

Waterway Manager: Parks Victoria

1.5.7 Five (5) knot speed restriction zones

All waters of North West Port Phillip unless designated as a five knot zone below are subject to a five knot speed restriction within 200 metres of the water's edge, excluding areas prohibited to vessels.

- (a) All the waters of Werribee River
- (b) Williamstown Maritime Precinct

The waters bound by the Williamstown foreshore and Port of Melbourne waters, from the end of Sandy Point Breakwater 2 (37° 51.106' S, 144° 54.332' E) to a point (37° 51.113' S, 144° 54.418' E) approximately 10 metres west of No. 24 port lateral pile, then south easterly to a point (37° 51.386' S, 144° 54.679' E) approximately 600 metres off the head of Boyd Pier at the Port waters of the Port of Melbourne port limits then south-west to the head of Boyd Pier (37° 51.685' S 144° 54.519' E), then easterly to Anne Street Pier at the Port waters of the Port of Melbourne port limits, then following the western side of the Anne Street Pier through to the shoreline.

SPECIAL

Insert into Clause **1.5.13 Exclusive use and special purpose areas**, after Clause 1.5.13(a):

(b) Williamstown Maritime Precinct – control of vessels

The following vessels are exempt from the provisions of Clause 1.5.7(b) of this Notice, and a master of these vessels must not exceed five knots within 200 metres of the Williamstown foreshore:

- (i) sea planes;
- (ii) vessels under sail.

SCHEDULE 2: Port waters of the Port of Melbourne

2.7 Speed Restrictions for the purposes of Clause 7

2.7.1 Five (5) knot speed restriction for the purposes of Clause 7

All vessels are subject to a speed limit of five knots on the waters of the Williamstown Maritime Precinct within the port waters of the Port of Melbourne from the Williamstown shoreline bound by the port limit, extending from the shoreline along the western side of Anne Street Pier, then west to the head of Boyd Pier¹, then north easterly to a point² approximately 600 metres off the head of Boyd Pier, following the Port of Melbourne port limits north west through a point³, to a point west of beacon 24⁴, then following the Williamstown Channel south east through points⁵⁻⁶, to a point west of beacon 22⁷ and a point west of beacon 20⁸ to a point west of Gellibrand Pier Light Bouy⁹, then south along the western side of Gellibrand Pier to the shoreline.

2.7.2 Six (6) knot speed restriction for the purposes of Clause 7

All vessels less than 35 metres in length, on the waters of the Yarra River within the port waters of the Port of Melbourne, between the southern drip line of the Westgate Bridge and the western drip line of the Bolte Bridge are subject to a speed limit of six knots.

2.7.3 Eight (8) knot speed restriction for the purposes of Clause 7

All vessels less than 35 metres in length, on the waters of the Yarra River within the port waters of the Port of Melbourne, between the southern drip line of the Westgate Bridge and a line joining beacons 23 and 24 are subject to a speed limit of eight knots.

2.13 Exclusive use and special purpose areas for the purposes of Clause 13**(a) Transit Only Zone**

The operator, master or person in charge of a vessel must not use the Transit Zone delineated on Map 1 below other than for transiting of the vessel and must not permit the vessel to be anchored in or allow the vessel to drift in the Transit Zone.

(b) Williamstown Maritime Precinct – control of vessels

The following vessels are exempt from the provisions of Clause 2.7.1 of this Notice, and a master of these vessels must not exceed five knots within 200 metres of the Williamstown foreshore:

- (i) sea planes;
- (ii) vessels under sail.

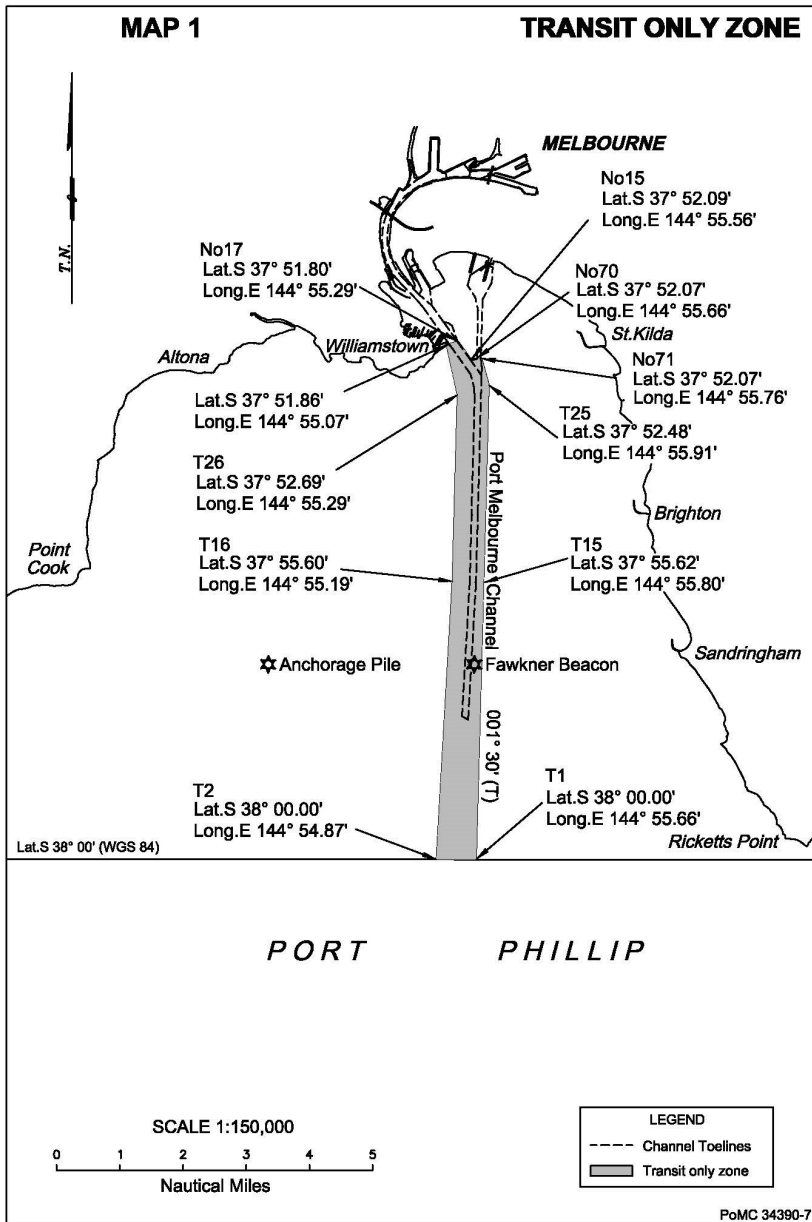
